The first installment of the approved grant will be released on receipt of the enclosed pre-receipted bill duly signed. The second and subsequent installments will be released on receipt of the six monthly progress report (3 copies) of the project submitted by the Project Director alongwith Statement of Expenditure in respect of previous installment, duly verified by the Finance Authority of the Affiliated Institute. The subsequent grant will be released only after the examination of the previous progress report by the expert if it found to be satisfactory. The overhead charges will be released only on receipt of a MSS/final work report which will be evaluated by the Council to ascertain the merit of the work.

The Project Director shall submit the final report (2 copies) of the project within three months of the end of the period of the project; five per cent of the entire grant of the project awarded under Clause 1, 2 and 4 shall be withheld, to be released on reimbursement basis only after the final statement of expenditure is received from the institution of affiliation, and the final report is found deemed satisfactory.

#### SANCTION ORDER

Subject: Project on "Impact of Skill Development Initiatives on Livelihood and Employment: A Study on the Sivasagar District of Assam"

Dear Dr Mahanta,

The Indian Council of Social Science Research North Eastern Regional Centre (ICSSR-NERC), Shillong considered the above mentioned research project proposal submitted by Dr Mrinal Ghosh, Assistant Professor, Department of Commerce, Gargaon College, Assam.

I am pleased to inform you that the Centre has sanctioned a grant-in-aid of Rs. 1,20,000/- (Rupees One Lakh Twenty Thousand) for the project which will be released in three installments as follows:

First Installment	:	Rs. 60,000/-
Second Installment	:	Rs. 36,000/-
Third Installment	:	Rs. 24,000/-

The First installment of the approved grant will be released after we have received the grant-in-aid bill (blank proforma enclosed) duly filled in. This may kindly be sent immediately.

If the study involves survey research in which schedules/questionnaires designed to elicit information are to be used, 2 copies of each of these finalized schedules/questionnaires should be sent to the ICSSR as per following schedule:



- (i) If the schedule/questionnaire for eliciting information is as per standard questionnaire, these will have to be sent to ICSSR-NERC immediately.
- (ii) If the schedule/questionnaire for eliciting information are to be designed afresh keeping in view the requirements of the project these will have to be sent to the ICSSR-NERC within a period of 4 months in any case.

The second installment will be released on receipt of a three monthly progress report on the project to be submitted by the Project Director and grant-in-aid bill in the prescribed proforma.

The final installment will be released only after the receipt of the following document under rule of the ICSSR-NERC Research Grant.

- (a) The final report of the research project in triplicate in publishable form.
- (b) A short summary in triplicate of the project report in 2,000-3,000 words for publication in the ICSSR-NERC annual report.
- (c) Such data or information relating to the project as may be asked for the by ICSSR-NERC for preservation in its Documentation Analysis Unit of the Centre.
- (d) Final soft copy in PDF & Word format in pendrive.
- (e) The audited statement of accounts for all expenditure incurred together with utilization certificate in GFR-12A form for the entire amount of the sanctioned grant along with grant-in-aid bill.

Dr Mrinal Ghosh will be the Project Director. He will be responsible for its completion within 12 months from the date of commencement of the project as intimated by the scholar.

In case the project report is not received within the stipulated period, appropriate action will be initiated against the Project Directors as per the terms of reference to the Agreement. In case the Project Director does not submit the periodic/final report as per schedule with adequate justification, the grantee may be debarred from all future financial assistance from the ICSSR-NERC.

All grants from ICSSR-NERC are subject to the general provision of GFR 2005 and in particular with reference to the provision contained in GFR 209, GFR 210, GFR 211 and GFR 212.

Purchase of laptop, desktop, printers and other equipments are not permitted. Payment for appointment of Research Assistant is also not allowed. However, payment to investigator for data collection is allowed.

The Project Director will ensure that the expenditure incurred by him/her conform to the approved budget heads. The grant-in-aid is subject to all the conditions laid down in the ICSSR Research Grants scheme, a copy of which is available in our website [www.icssrmerc.org](http://www.icssrmerc.org).



The expenditure on this account is debitable to the Budget Head (OH-31) – Research Projects.

As per Ministry of Education instruction, the amount of grant sanctioned herein is to be utilized by the end of the project duration. Any amount of the grant remaining unspent shall be refunded to the ICSSR-NERC immediately after the expiry of the duration of the project.
