- The Girl students belonging to minority community must be a domicile of Assam, who has secured not less than 50% marks in the previous qualifying examination. Permanent Residence Certificate issued from D.C./S.D.O. (Civil) is MANDATORY. P.R.C issued by others will not be accepted.
- 2) The Girl students must belong to a notified minority community i.e Muslims/Silds/Quriettans/Buddhists/Jelms and Parale.
- 3) The annual income of their parents/ guardises from all sources should not exceed Rs. 2,00 labits only. Income Cartificate issued by concerned flevenue Carde Officer is required in respect of parent(s)/guardian(s) of the student MANDATORY, Income Cartificate issued by others will not be accepted.
- 4). A Self-Certified Community Certificate is required from the student countersigned by Circle Officer where the student is residing.
- 5) The acholership shalf be awarded to regular students students students of Govt./Provincialised Colleges, Central & State Universities, Medical Colleges, Engineering Colleges, Polytechnic in <u>Underwradiante</u>, <u>Graduate and Post-Graduate Levels</u>.
